Dear Supervisors:

Please accept this letter as our Annual Engineer's Report. During the past year our assistance to the Cow Slough Water Control District has consisted mostly of providing information from our files and responding to inquiries. Johnson-Prewitt & Associates has continued to attend the monthly meetings.

Last year, our office was contacted by the Florida Department of Environmental Protection (FDEP) regarding the Basin Management Action Plan (BMAP) requirements for lands within the Caloosahatchee River and Estuary Basin. FDEP required all water control districts to submit a Best Management Practices (BMP's) plan to limit nutrients in the water control district's runoff. A plan for the District was submitted and accepted by FDEP in January 2020. An agenda item for Public Education and Outreach will be added to the landowner's meetings as a part of the Districts BMP implantation.

The FDOT improvements on State Road 82 and State Road 29 within the District will be ongoing for the next several years. As needed, updates will be provided to the Board.

#### RESOLUTION

WHEREAS, Chapter 197, Florida Statutes, provides two viable alternatives for the levy and collection of existing special assessments; and

WHEREAS, Section 197.363, Florida Statutes, allows a taxing authority, at the option of the Property Appraiser, to continue to collect special assessments utilizing the county method of tax collection; and

WHEREAS, Section 197.3632, Florida Statutes, allows a taxing authority to utilize a uniform method of levy and collection of non-ad valorem assessments upon passage of a resolution determining to do so; and

WHEREAS, the Property Appraiser may agree to enter into an agreement with the District pursuant to Section 197.363, Florida Statutes, to continue to collect special assessments for 1993 and thereafter pursuant to that section of law; and

WHEREAS, the Board may determine it is in the District's best interest to utilize Section 197.3632, Florida Statutes, for 1994 and years thereafter; and

WHEREAS, the Board determines it is in the best interest of the landowners of the District to authorize utilization of both methods in the discretion of the Board of Supervisors; and

WHEREAS, legal description of the District, being the real property subject to the levy, is as follows:

### **HENDRY COUNTY**

In Township 45 South, Range 28 East: All of Sections 13, 14, and 24; and Section 25 less the following described parcel: Commencing at the southwest corner of said Section 25; thence N. 0-39-29 W. along the west boundary line of said Section 25 a distance of 665.19 feet to the Point- of- Beginning of this description; thence continuing N. 0-32-29 W. along said west boundary line of Section 25 a distance of 4656.88 feet to the northwest corner of said Section 25; thence S. 87-56-46 E. along the north boundary line of said Section 25 a distance of 1950.00 feet; thence S. 0-27-54 E. a distance of 1176.05 feet; thence S. 0-53-38 E. a distance of 2450.41 feet; thence S. 0-34-26 E. a distance of 1025.07 feet; thence N. 88-07-20 W. a distance of 1963.85 feet to Non-ad Valorem Resolution the said Point-of-Beginning of this description.

In Township 46 South, Range 29 East: All of Section 5 west of State Road 29; all of Section 6; that portion of Section 7 north of State Road 82; all of Section 8 West of State Road 29; and, that portion of the North 1/2 of Section 17 west of State Road 29.
